NOTIFICATION

The draft of the following rules further to amend the Karnataka Civil Services (Computer Literacy Test) Rules, 2012, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of Section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of Section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in Official Gazette.

Any objection or suggestion which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above will be considered by the State Government. Objections or Suggestions may be addressed to the Secretary, to Government, Department of Personnel and Administrative Reforms, Vidhana Soudha, Bangalore-560 001.

DRAFT RULES

JD (Ad) / Reg (Ad)

1. **Title and Commencement:-** (1) These rules may be called the Karnataka Civil Services (Computer Literacy Test) (Amendment) Rules, 2017.

(2) They shall be deemed to have come into force with effect from 22.03.2012.

2. Amendment of Rule 2:- In the Karnataka Civil Services (Computer Literacy Test) Rules, 2012, in rule 2,

- (a) after the words "as may be prescribed by the Government" the words "by securing not less than fifty percent of marks" shall be inserted.
- (b) for the words "five years", the words "eight years" shall be substituted.

3. Amendment of rule 3.- In rule 3 of the said rules,-

(a) in sub-rule (1),-

- (i) for the words "five years" the words "eight years" shall be substituted; and
- (ii) for the words "six years" the words "nine years" shall be substituted.

(b) in sub-rule (2), for the words "five years", the words "eight years" shall be substituted.
