The draft of the following rules further to amend the Karnataka Civil Services (Performance Reports) Rules, 2000 which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in Official Gazette.

Any objection or suggestion which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above will be considered by the State Government. Objections and suggestions may be addressed to the Principal Secretary to Government, Department of Personnel and Administrative Reforms, Vidhana Soudha, Bangalore-560 001.

### DRAFT RULES

**1. Title and Commencement.-** (1) These rules may be called the Karnataka Civil Services (Performance Reports) (Amendment) Rules, 2018.

(2) They shall come into force from the date of their final publication in the official Gazette.

**2. Amendment of Rule 2.-** In the Karnataka Civil Services (Performance Reports) Rules, 2000 (hereinafter referred to as the said rules), in rule 2, in sub-rule (1),-

- (i) for the words "Performance Report is written", wherever it occurs, the words "Performance Report is recorded" shall be substituted.
- (ii) in clause (e), for the words "a report written", the words "a report recorded electronically in respect of Group-A officers and physically in respect of Group-B and C officials" shall be substituted.

**3. Amendment of Rule 3.-** In rule 3 of the said rules, in sub-rule (2), in clause (a), for the words "written under these rules", the words "recorded electronically in respect of Group-A officers and physically in respect of Group-B and C officials under these rules" shall be substituted.

**4. Amendment of Rule 4.-** In rule 4 of the said rules, in sub-rule (1), for the words "shall be written", the words "shall be recorded electronically in respect of Group-A officers and physically in respect of Group-B and C officials" shall be substituted.

**5. Amendment of Rule 5.-** In rule 5 of the said rules,-

- (a) in sub-rule (3), in clause (a), for the words "has not been able to write", the words "has not been able to record" shall be substituted;
- (b) in sub-rule (4), for the words "shall also be written", the words "shall also be recorded" shall be substituted; and
- (c) in sub-rule (5), for the words "could not be written", the words "could not be recorded" shall be substituted.

**6. Amendment of Rule 7.-** In rule 7 of the said rules, in the explanation (1) and (2), for the words "need not be written," the words "need not be recorded" shall be substituted.

**7. Amendment of Rule 7A.-** In rule 7A of the said rules, for the words "report is not written", the words "report is not recorded" shall be substituted.
